A Reminder to Winterize Your Irrigation System

Every year, it's a ritual. From Maine to Minnesota to Montana - and anywhere the frost level could extend below the depth of installed pipe - getting an irrigation system ready for the change of seasons is an annual event.

Homeowners need to be aware that over the years, the effects of repeated water expansion inside pipes can weaken those pipes and lead to fractures. Plus, if the fittings and the pipe do not expand and contract at the same rate during seasonal temperature changes, the matter of material stress will be called into question.

Of course, if the system contains PVC pipe there is no question....because, when it's more than half full of water and frozen, PVC pipe will crack - most often from fitting to fitting (i.e., along the length of the pipe). Advise your customers to winterize their system to protect it.

Thanks to everyone who made the TBPA Conference a success. A good time was had by all. I look forward to seeing everyone next year in Gatlinburg. Plan now to attend!

Treasurer's report


We apologize that the Febco repair class that was scheduled for November 17th had to be canceled. There were timing issues but Michael Ray with Febco

TAUD and DWS Reach Agreement on 5% Cross Connection Control Inspection

The TN Department of Environment and Conservation (TDEC) Division of Water Supply (DWS) conducts sanitary surveys of water systems to evaluate their performance in accordance to applicable statutes, regulations and policies. These surveys include all aspects of the water treatment and water distribution systems including the cross connection control program. Several water systems, primarily in Middle Tennessee, have recently received comments associated with their surveys that were interpreted as requiring a cross connection plan update including an inspection requirement of five percent of their residential customer base that were not currently protected by backflow prevention assemblies. These comments raised concerns by most water systems because of the potential manpower requirements necessary to accomplish these actions. Some systems wrote these requirements into their plan and had them adopted by their governing bodies and accepted by TDEC, while others, fearing that they could not achieve this goal, have delayed and sought other options. Many have requested TAUD's assistance in this matter and as a result, TAUD and the DWS have exchanged correspondence, met and agreed on a schedule and process to work through these issues.

To begin this process, the DWS has emailed the following statement to each field office:

For quite some time, the DWS has considered initiating efforts to amend Division Rule 1200-5-1-.17(6) to define or establish minimally acceptable components to be included in cross connection control ordinances or policies and programs and plans. Such amendment should serve to clarify requirements of water utilities as well as simplify the review processes for Division staff. The Division intends to initiate this process in the near future and has discussed this issue with representatives of TAUD and TBPA. The Division plans to collaborate with TAUD and TBPA as well as other interested parties during the course of this endeavor.

During this period of planning, defining of terms and establishing minimal standards, field office staff are requested to maintain flexibility in review of cross connection documents, specifically

including levels of activity in surveys and re-surveys of connections within the distribution system. During this period, the survey inspection goal of 5% of unprotected service connections should be suspended until such time that a standard is established and additional guidance provided. Likewise, it is not recommended that water utilities adopt this standard or place it into cross connection documents at this time.

To complete this process, an ad hoc committee will be formed to draft regulations, related policy and guidelines, and define terminology such as "survey" and "inspection" to clarify any misunderstandings. The committee should begin meeting in January 2011 and will have a goal of completing their work by the end of March 2011. Rules suggested by this committee will be subject to the normal rulemaking process which includes public meetings and opportunity for public comment.
