

Gatlinburg, TN proved to be an ideal location for the 2000 Conference for the Tennessee Backflow Prevention Association.
Conference attendance was high at approximately 80 attendees including speakers. The Conference was packed with informative speakers and vendors from around the country. All areas of cross connection control were represented from the installers to the regulatory agencies.

Speakers for the 2000 Conference were Douglas Creagor, an attorney with expertise on Cross Connection Control, Jack Poole, the ABPA President and Jim Purzycki, from BAVCO.

Test kits were verified for accuracy using a set of water columns recommended by the Foundation for Cross Connection Control. Most gauges were determined to be accurate, but many were discovered to be reading incor-

rectly. Once a gauge has been determined to be out of calibration, it must be sent to the manufacturer or qualified certification lab for service.

After 43 1/2 years of service to the citizens, water utility operators and water system managers of Tennessee, Robert W. Lashlee has decided it is time to pursue some of his many other interests. On February 28, 2001, Robert Lashlee will retire from state service.

In the spring of 1957, Julian R. Fleming became the Director of the Tennessee Division of Sanitary Engineering following the death of R. P. Ferrell. Robert Lashlee was one of the first persons hired by Mr. Fleming. Robert came to work for the Division on September 3, 1957 as a Junior Sanitary Engineer. Some of Robert's first duties were conducting sanitary surveys, investigating complaints, troubleshooting water system problems, and training operators. Later on he became involved in the state's fluoridation program and was responsible for purchasing and overseeing the installation of fluoridation equipment in community water systems. Robert was later in charge of the review and approval of water projects.

In the early 1970's, Robert became more focused on the issue of cross connections and began efforts to develop the cross connection program as we know it today. Prior to Robert's involvement very little emphasis had

been placed on cross connections even though state law prohibited the creation of a cross connection in a public water system. Robert was responsible for developing training classes specifically directed toward developing and implementing a cross connection program in a public water system. These training



programs lead to the establishment of a certification program for persons installing and testing backflow protection devices. Robert also authored Tennessee's Cross Connection Manual. Robert has dedicated over 25 years of his state career to the cross connection program and could be considered the father of Tennessee's Cross Connection Program.

While with the state, Robert has been an active member of the Tennessee Water and Wastewa-

ter Association (TWWA), the American Water Works Association (AWWA), and the Tennessee Chapter of the American Backflow Prevention Association (ABPA). Robert has served as Chair of the Kentucky-Tennessee Section of AWWA and is a recipient of the Fuller Award. Robert is a life member of AWWA and was selected for Honorary Life Membership in the Tennessee Chapter of ABPA. Robert has been a registered professional engineer in Tennessee since September 23, 1963 and is among the very few who has also achieved recognition by the American Sanitary Engineering Intersociety Board.

With Robert's retirement the Division of Water Supply loses 43 1/2 years of experience and knowledge that will be extremely hard to replace. Few individuals have been as dedicated to a program as Robert has been concerning cross connections. In reviewing past records, no other person has given so much of himself or herself to Tennessee's water supply program as Robert Lashlee.

We wish Robert the very best as he pursues other interests and takes more time to spend with his family, his new grandchild and his lovely wife Georgia. Thanks for your dedication and service to the water supply industry.


Manufacturer Spotlight: SAFE-T-COVERTM Enclosures

HydroCowl, Inc. was the brainstorm of Mr. Dean Davenport, a veteran utility contractor with 30+ years of experience installing water and fire sprinkler mains. Dean recognized the need for a standardized design for an aboveground enclosure for backflow assemblies that provided adequate freeze protection and easy access for testing and maintenance while being cost effective and simple to install. HydroCowl, Inc. began selling enclosures in the Nashville, TN. area in the late 1980's.

During 1998, HydroCowl began researching new trade names for its enclosure products as a response to concerns from reps and distributors across the U.S. that HydroCowl was losing the name recognition game to its primary enclosure competitor. The new trade name and logo, SAFE-T-COVERTM, was adopted in the summer of 1999. To much of the industry outside Tennessee, HydroCowl is now known as SAFE-T-COVERTM. SAFE-T-COVERTM has manufacturer's reps from Nova Scotia, Canada in the east to Hawaii in the west.

SAFE-T-COVERTM enclosures are manufactured with a metal skin (aluminum, galvanized steel or stainless steel), 1.5" insulation (R 10), removable access doors, and hinged roofs on some models. Standard enclosure sizes range from 3/4" single backflow preventers through installation of dual



10" assemblies. Safe-T-Cover enclosures provide freeze protection through a patented, liquid-tight slab-mount heating system which is designed to withstand water spray from a Reduced l'ressure assembly relief valve. The slab-mount heater is installed directly onto the concrete slab and provides consistent heating from the lowest to the highest point of the installation. Standard wall mount heaters, which must be installed away from spraying water, and heat cables are also offered.

Safe-T-Cover's customer service is second to none. Three Cad technicians provide

support on project design work, creating details of the enclosure and the enclosed backflow preventer, meter, control valve, etc. The Safe-T-Cover sales support staff is experienced in system design and installation as well as the water industry. Most customer orders are shipped from stock.

As more and more cities and states recognize the need to create effective cross connection control programs, the consideration of how to install backflow preventers drives the need for enclosures. The need for installation of Reduced Pressure (RP) assemblies in enclosures is an easy consideration for the industry due to the high volume of potential water relief. Double Check (DC) assemblies have historically been installed below grade in the Southeast; however, the tide is changing. The State of Mississippi adopted new regulations for cross connection control, Part 301 of their Primary Drinking Water Regulations, effective August 1998. The new Mississippi regualtion requires RP and (DC) assembly installation above grade. The Autumn 1997 addition of USC FCCCHR's Cross Talk warned of the potential contamination through the test cocks of DC assemblies installed below grade.

The Safe-T-Cover line of enclosures and heaters enjoys continued growth through the extraordinary efforts of its reps, distributors, and friends in the industry. Safe-T-Cover is committed to supporting the cross connection and drinking water industry's efforts to effectively provide communities clean and safe drinking water.
