

2005 TBPA Conference Presentation

My presentation at the Conference this year covered the many aspects of the Administration and Survey Class started by TBPA. I introduced the new TBPA CD that was produced to help bring continuity to the cross connection program. Every water purveyor in the State of Tennessee is required to have an ongoing, working cross connection program. This CD was designed to assist water purveyors develop and maintain their cross connection programs. The CD is divided into three sections-Forms, Drawings, and Database.

The Forms Section contains letters for first time inspections, annual testing or inspections of backflow devices. These letters can to be used to contact customers and inform them of upcoming work that is to be done. Also, located in this section is other information that would be useful to the person administrating the cross connection program. For example: a copy of the State Manual, Thermal Expansion letter, other form letters that can be changed to fit the individuals needs and to help the cross connection administrator.

The Drawings Section will put into your hands, 9 different drawing on the installation of a backflow device. This program will allow the user to change the wording to inform the installer of the device and how the backflow device is to be installed. By giving one of these drawing to the installer doing the work, they will have less problems with installation. The installer using your specs can avoid future conflicts.

The Database Section is in Access format. Access will need to be installed on the users' computer. This section has 4 different tabs. The Customer tab has a place for important customer information, for example: Name, Address, Telephone number, etc. The tab for Assemblies has a place for all information on the devices that are at each customer location. This tab will help in keeping up with test dates and when testing is due. The Report tab will generate many different types of reports, for example, single customer information, customers by name, customers by priority, assemblies test status, test summary, next inspection date, testers list, testers profile, and much more. The Testers tab allows the user to enter and keep information on all testers. The testers could be working for the water purveyor or they could be an outside contractor. Some of the information you will be able to keep on them are, name, Company name, when their license renewal is due, the type of equipment they are using, calibration due date on that equipment, etc.

After many months of hard work the CD is ready for distribution. The CD cost to members of TBPA is \$25.00 and to non-members is \$95.00. The non-member cost includes a one-year membership in TBPA and ABPA.

We will make annual updates to the program and keep those who have the CD informed of those updates. Our goal is to help each of you with your Cross Connection Program and we welcome your suggestions. Your suggestions let us to know how to best update the program to fit your needs. If you, or someone you know would like more information about the CD, contact any TBPA Board member.

Winterize Your Irrigation System

Every year, it's a ritual. From Maine to Minnesota to Montana and anywhere the frost level could extend below the depth of installed pipe - getting an irrigation system ready for the change of seasons is an annual event.

Homeowners need to be aware that over the years, the effects of repeated water expansion inside pipes can weaken those pipes and lead to fractures. Plus, if the fittings and the pip do not expand and contract at the same rate during seasonal temperature changes, the matter of material stress will be called into question.

Of course, if your system contains PVC pipe there is no question. Because, when it's more than half full of water and frozen, PVC pipe will crack - most often from fitting to fitting (i.e., along the length of the pipe). You need to winterize your system to protect it.

"Blowing Out" a System with an Air Compressor

Unless your system has manual or automatic drains, you will need to "blow out" water in the system with a portable air compressor in order to winterize. And it's rather easy.

After turning off the water, connect the compressor (100 CFM for pipe with 2" diameter or less, 250 CFM for pipe 4" or larger) to inject air into the system near the main shutoff. Turn off the compressor and activate the zone of sprinklers at the highest elevation and furthest from the compressor before opening the valve on the compressor. Be careful to introduce air into the system gradually to avoid high pressure surges. Then, slowly increase the air pressure to 50 psi to reduce the chance of water ram damaging the components. If the sprinkler heads do not pop up and seal, adjust the pressure upward until they do, but NEVER let the air pressure exceed 80 psi.

It usually takes about two minutes or more to evacuate each zone. Proceed in sequence through all the zones, eventually ending up at the part of the system closest to the compressor and at the lowest elevation.

Go twice through the entire system, using a short cycle on each pass rather than a single long one, as repeating the process completely removes water that has drained from one zone into another on the first cycle. It also helps reduce the amount of time compressed air is moving through dry pipes (such friction can cause heat damage).

Some Final Info

Got a controller? Be sure to leave your power on and the rain or station start switch in the off position to prevent condensation inside the controller enclosure.

Have a backflow device with ball valves?

After shutting off the water supply and draining the system, remove any water trapped in the valve bodies by opening and closing them several times with the lever handle. Then, leave the handle at a 45-degree angle, so the valve is partially open. Preparing a hydraulic control system?

Close and disconnect the potable water supply line to the signal control tubing and drain the tubing.

No mater where your system is located, the same rules apply.

Remember

Don't allow air pressure to exceed 80 psi, especially in systems designed to operate below this pressure level.

Don't stand over component parts while the system is under pressure.

Don't leave the compressor unattended.

Don't blow out the system through a pump. First blow out the system, then drain the pump.

Don't leave manual drain valves open. Water could enter the system during winter thaw.




